Dear Stakeholders and Interested Parties,

The U.S. Department of the Interior (DOI), Office of Surface Mining Reclamation and Enforcement (OSMRE), Western Region Office, has prepared an environmental assessment (EA) for the Jim Bridger Coal Mine complex (Bridger Mine Complex) mining plan modification for federal coal lease WYW-02727 (the Project). Since 1974, in accordance with the Mineral Leasing Act of 1920 (MLA) and the federal mining plan approved by the Assistant Secretary for Land and Mineral Management (ASLM), the operator of the Bridger Mine Complex (currently Bridger Coal Company (BCC)) has mined portions of federal coal leases, including federal coal lease WYW-02727, in accordance with the approved surface coal mining permit issued by the state regulatory authority, the Wyoming Department of Environmental Quality, Land Quality Division (WDEQ-LQD). On November 28, 2014, in accordance with its responsibilities under the Federal Surface Mining and Reclamation Control Act of 1977, the WDEQ-LQD approved the Amendment and Mine and Reclamation Plan Revision for surface coal mining Permit No. 388-T7, including the mining of additional portions of federal coal lease WYW-02727, not previously approved by the ASLM. In accordance with MLA, the ASLM must approve the mining plan modification for federal coal lease WYW-02727 before mining of the federal coal can occur.

OSMRE has prepared this EA to evaluate the environmental impacts resulting from the Project, pursuant to the requirements of the National Environmental Policy Act of 1969 (NEPA). The Bridger Mine Complex is located approximately 35 miles northeast of Rock Springs, Wyoming. It produces upward of 6 million tons of coal per year, supported by 4.0–4.5 million tons of coal from the underground operation and 1.0–1.5 million tons from the surface operation. BCC proposes to add 560 federal surface acres and 4.5 million tons of federal coal to the approved federal mining plan. The proposed mining plan modification would result in an annual production increase of 3-5% after 2025, allowing the mine to maintain existing annual production levels until 2037, when combined with future mining on adjacent lands. After 2025, the average annual production of coal mined at the Bridger Mine Complex would increase from between approximately 3.5 and 6.3 million tons to between approximately 3.7 and 6.5 million tons of coal per year. This mining plan modification would allow approximately 215,000 tons of federal coal per year to be mined on average. The life of the mine would not be extended by the mining plan modification.

The EA discloses the potential for direct, indirect, and cumulative impacts to the environment from the Project. As a result of the EA process, OSMRE has determined there are no significant environmental impacts and has issued an unsigned Finding of No Significant Impact (FONSI). The ASLM will approve, disapprove, or conditionally approve the mining plan approval document within the mining plan decision document, as required under the Mineral Leasing Act of 1920.


