Dear Stakeholders and Interested Parties,

The Office of Surface Mining Reclamation and Enforcement (OSMRE) Western Region is extending by 14 days the public comment period on the environmental assessment (EA) and unsigned Finding of No Significant Impact (FONSI) for the Spring Creek Mine's mining plan modification for federal coal lease MTM 94378. Interested parties will now have until July 19, 2016 to submit comments. All comments must be received or postmarked by July 19, 2016 to be considered.

The U.S. Department of the Interior (DOI), Office of Surface Mining Reclamation and Enforcement (OSMRE), Western Region Office, has prepared an EA for the Spring Creek Mine's (SCM) mining plan modification for federal coal lease MTM 94378 (Spring Creek Mine LBA 1 EA [the Project]). Federal coal lease MTM 94378 was issued by the Bureau of Land Management (BLM) in December of 2007. The DOI Assistant Secretary for Land and Minerals (ASLM), in accordance with the Mineral Leasing Act of 1920, subsequently approved SCM's federal mining plan modification to include federal coal lease MTM 94378 on June 27, 2012. The 2012 Spring Creek federal mining plan approval authorized surface coal mining on 1,117.7 acres of federal coal within MTM 94378. SCM commenced mining in federal coal lease MTM 94378 in 2012 in accordance with its state mine permit and federal mining plan modification approvals and, as of December 2015, approximately 18.4 mmt of the 103.2 mmt of federal coal included in the 2007 BLM MTM 94378 lease sale had been recovered. The SCM is located approximately 32 miles north of Sheridan, Wyoming (see attached map). The SCM uses a combination of dragline and truck shovel mining methods.

Because of a recent court decision, OSMRE has prepared this EA to reevaluate the environmental impacts resulting from the originally proposed and currently approved mining plan modification for federal coal lease MTM 94378, pursuant to the requirements of the National Environmental Policy Act of 1969 (NEPA). See January 21, 2016 order of the U.S. District Court for the District of Montana, in case *WildEarth Guardians v. U.S. Office of Surface Mining Reclamation and Enforcement et al.*, Case 1:14-cv-00013-SPW (D. Mont.). The EA updates, clarifies, and provides new and additional environmental information for the Project. As a result of the EA process, OSMRE has determined there are no significant environmental impacts and has issued an unsigned Finding of No Significant Impact (FONSI). The ASLM will approve, disapprove, or conditionally approve the mining plan approval document within the mining plan decision document, as required under the Mineral Leasing Act of 1920.
